- Your Federation worked with Kington Langley to support John Grimshaw being one of the first recipients of the Bernard Neal Award for his services to Croquet, not forgetting everything he has done and is still doing, for the South West (e.g. 14 years as our League Secretary)

Judith Moore Bursary

Treasurers AGM Report 15th November 2020

Financial Year-End Accounts (see page 3)

As expected, the impact of coronavirus on the Federation's finances has been substantial leading to a loss of just over £400. Fixed Costs incurred have largely been offset by donations received from member clubs. The losses are more than adequately covered by available reserves of over £5,200.

Refund of Fees

A Refund of full membership, League and Short Croquet fees was offered to member clubs. The Treasurer would like to give thanks to the following clubs who in total have made donations of £695 to SWF Funds: Camerton & Peasedown

Financial Year-End

The date for the financial year end should be such that it as close as possible to the AGM, and therefore provides the most up to date information but also gives sufficient time to the Treasurer & Examiner to complete their responsibilities.

There was discussion at the 2019 AGM of moving the October 31st financial year-end to an earlier date to give the Treasurer more time. However, I can confirm that transactions that are notified but not yet paid / received by October 31st can be fully reflected in the accounts and this follows normal accounting practice. As such I expect the accounts to be prepared by the Treasurer on November 1st and an agreed version of the accounts following feedback from the Examiner a few days later.

Therefore, I propose that the financial year-end remains October 31st and is only changed due to exceptional circumstances.

Judith Moore Bursary

During the year there was a donation of £5,000 to the Judith Moore bursary this has been identified in the accounts as Tournament Development Fund. As yet there have been no grants provided under the bursary, but it is anticipated that there will be further promotion of this scheme and grants to be given during 2021.

Fee Proposals for 2021 & Level of Reserves

At the year-end reserves are just over £5,200 which at 210% of 2019 turnover of c£2,500 (excluding costs of printing SWAN) which in the Treasurer's opinion appears to be rather high. There are further reasons to believe these reserves are high:

1. Income & Expenditure are comparatively stable.
2. Fixed costs are low
3. Around 50% of expenses are "internal" to member clubs (Lawn Fees), and represent transferring of funds from one group of member clubs to another.

I therefore propose that these surplus reserves are distributed to member clubs over a number of years by setting fees to give a small projected budget loss (a loss of £200 for 2021) and keeping fees suppressed.

I look forward to receiving feedback from clubs on this proposed approach, and on whether quicker / slower distribution of reserves is appropriate.

SWAN printing costs for 2020 were substantial at £710, as it has been agreed that this is the last year for which SWAN will be printed then my proposed fees for 2021 pass this reduction in costs on to member clubs in the form of lower fees.

The combined impact of projecting a small loss for next year and the saving of SWAN printing costs gives the following proposed fees for 2021.

For 2021 the structure of fees shall be as follows - a discount for early payment is proposed to ensure that payment is made in a timely manner consistent with the timetable for the organisation and start of League play. This will be applied if payment is received on or before March 7th 2021.

SWF League Secretary Report

I have no activities to report as there have been no matches. The only friendly match I was to be involved in (Sidmouth v Taunton Deane) was cancelled when new restrictions were announced.

We have a proposal for a rule change that brings the deadline for submitting match dates forward by 1 week (to Jan 24th) and I see no reason to change that.

I have now heard back from the majority of the clubs' Match Secretaries and no-one is opposed to the rescheduling of the 2021 deadlines.

My additional proposal is therefore that, for this year only, we plan to delay starting match organisation by about 3 months. The actual proposal, is:

“For the 2021 season only, the dates for submission of league team entries and the circulation of dates to the clubs shall be:

Mid-February 2021	League entry forms will be sent to club Match Secretaries.
Sunday March 7 th 2021	Deadline for all team entries to be submitted by the clubs to the League Secretary.
Sunday March 14 th 2021	League Secretary to send out Blocks and Match venues to all club Match Secretaries.
Sunday April 11 th 2021	Deadline for agreed match dates to be sent to League Secretary, together with team captains and their contact details.
Sunday April 18 th 2021	League Secretary to send out all fixture lists and contact lists to club Match Secretaries, and to update the website tables.

The dates for payment of membership and match fees will also be delayed to be consistent with these revised dates.”

SWF Development Officer Report 2020

CA Grants and Loans 2019/2020

I am pleased to report the following grants and loans were awarded to the following SWF clubs.

- November 2019 Camerton and Peasedown
- November 2019 Winterbourne Valley (formerly Kingston Maurward)

- July 2020 Moreton in Marsh

CA Grants and Loans 2021

There is commitment from the CA Development committee to maintain the existing level of annual funding available for club grants. This committee now meets on a far more regular basis and so clubs can make grant applications at any stage of the year. In addition to grants, the CA is looking to offer more interest free loans (more information to follow).

As the 2019/20 list of grants and loans testify, clubs in the SWF have been successful with obtaining funding for their development plans and I would urge clubs to consider how they might benefit from grants and/or loans in 2021.

Welcome to Moreton in Marsh

We have regularly kept SWF clubs up to date via Cygnet and SWAN with news from Moreton in Marsh. It is pleasing to report that the new club is on course to begin playing on its two newly laid lawns in the Spring.

The new committee at Moreton in Marsh are to be congratulated on their resilience when surmounting a wide range of obstacles. Alongside their own impressive fundraising activities, the club has benefited from a £5,000 CA grant. The signs are positive for further CA financial support in 2021 in order for the club to complete stage two of its plans which include a clubhouse storage and lawn equipment.

We are confident that Moreton in Marsh will become a very successful croquet club and valuable member of the SWF. We are sure it will not be long before Moreton in Marsh will be hosting SWF league matches and providing a warm Cotswold welcome to visitors.

CA Club Awards

These bi-annual awards have already been promoted in Cygnet and Zoom meetings but here is a quick summary of the three categories.

- Apps Healey is for clubs with one or two lawns
- Townsend is for clubs with three or four lawns
- Millennium for clubs with five or more lawns.

Each award is worth £250 and SWF clubs have fared well since the awards were introduced. In the last round of awards, The Apps Heley was awarded to St Agnes. Other recent winners include Camerton and Peasedown, and Bath. If you feel your club would like to consider applying, I am happy to help and support club applications.

Future Zoom meetings

The first lockdown encouraged the committee to re-think how we communicated with SWF clubs. There is no doubt that the introduction of the monthly Zoom meetings has given our clubs the opportunity to communicate on a regular basis. Our CA representatives have also attended these meetings and have briefed us on CA news.

Overall, we have been pleased with the quality of our SWF Zoom meetings. Attendance has been good but we would warmly invite all our clubs to attend these monthly one hour 'get togethers' where we share latest news and ideas.

In addition, we are trying to bring the CA 'closer' to our federation and hope in the future to invite Executive Board members to attend to explain their roles and for them to hear directly from SWF clubs in regular Q & A sessions.

In past meetings we have had presentations from Chris Roberts (CA Gazette Editor) and Paul Hetherington (Marketing and Communications). Other CA officers have indicated their interest in meeting with us in 2021.

However, the agenda for the Zoom meetings should be driven by the clubs and so please let me know of issues and content you would like to be included.

SWF Coaching and Handicapping Report for AGM 2020

The Covid pandemic has almost entirely stopped croquet coaching at the national and regional level in 2020, but at the club level in the SWF there has been a patchwork of activity.

Some clubs have had little activity, with coaches shielding. Several others have reported increased activity in recruitment (and coaching). The early resumption of croquet as a good socially-distanced sport gained us publicity and aroused interest in the general public, which resulted in a number of clubs reporting increased recruitment, without a great deal of marketing activity at the club level. The need for individual or small group coaching instead of the customary larger groups has strained coaching resources, but in some cases resulted in very rapid improvement of promising beginners.

There have been experiments in online coaching. I have run two AC courses on break-building without bisesques. The method is no substitute for on-court coaching, but allows a more rapid discussion of tactical positions than is possible on court, and has allowed us to reach players from clubs with no qualified coach. A programme of Zoom sessions on the rules of GC has received enthusiastic support. These initiatives should continue after the pandemic.

A Coaches Refresher Course was planned to be held in Bristol last spring, to be run by three of the Federation's most experienced coaches. There was a very good projected attendance. Unfortunately, this had to be postponed because of the pandemic. We hope to be able to run it in 2021, with priority given to those who signed up this year.

Ill health forces me to relinquish the position of Federation Coach after a five-year stint, but I will remain in place for a short time until a successor can be found. I have greatly enjoyed my time in this position, and the opportunity to serve on the SWF Committee and the CA Coaching Committee.

Handicapping

For the past two years, I have also acted as Federation Handicapper. The SWF has taken a number of initiatives recently, with a series of handicapping workshops working towards a club handicapper for each club for the relevant code or codes. We have followed this up with an analysis of the league results for the SWF handicap leagues at the end of each season. Statistical analysis provides indications if a club's handicaps for a particular code have drifted away from the national norms and corrective action can be taken if necessary. These initiatives are being considered by the CA Handicapping Committee and may be rolled out nationally.

The almost complete lack of competitive play this year will mean that many players who have recently started will have improved their play much faster than their handicaps have changed under the Automatic Handicap System. Club Handicappers need to be alert to the need to make non-automatic changes where necessary. All players have a role to play in this. My suggested Mantra is

“Five wins in a row - Let your Club Handicapper know!”

If there is a problem, please contact the Federation Handicapper, who will try to find a CA Handicapper close to the club to resolve the problem. Croquet is much more enjoyable when all players have the right handicap!

SW Representatives to CA Council Report

The main items covered in Council can be summarised in Jonathan Isaacs report to the CA AGM. all three of us contribute to Council meetings in which we are able to influence the Strategy of your Governing Body.

Each Representative also undertakes other specific tasks which usually happen in a committee or working group.

Klim Seabright:

The Handicap Committee handles regular enquiries about the application of handicaps. It has also issued updated guidance for Club and CA Handicappers. There is a need for more Handicappers and it is probably best, in the first instance, to make contact with your Federation Handicapper.

The Marketing Committee made strong use of the COVID situation to emphasise the advantage provided in croquet for social distancing. This led to some good national publicity. It was noted that some clubs also ran their own campaigns and the impression is that recruitment levels have been good.

The Marketing Committee also initiated additional merchandise through the CA shop. If you are about to do your Christmas Shopping then do take a look at the new jewellery range. The virus mask was described by one customer as “the most comfortable mask I have worn and at a reasonable price”.

Communication with members and Federations have been improved via Zoom and Webinars both by the initiative of Eugene Change (Chair of Marketing), supported by committee members, and also by initiatives taken by the Federation. The monthly Newsletter has also been very positively received with around 65% of despatched emails being opened.

Diversity will be one of the central themes in the next year and SW will be represented on the Working Party.

I continue to attempt to have croquet included as a side event (not allowed to call it “demonstration”) in the Commonwealth Games in 2022. It is a bit heavy going though.

I have only received one question from a constituent which was easily resolved.

Peter Nelson:

CA Council Working Group on Membership - progress report

A working group comprising five members of Council has been established to review the membership structure and benefits for both clubs and individual members. The work is ongoing but a number of changes have been, or are in the process, of being implemented.

Prior to 2009 established clubs having the use of dedicated facilities were only eligible for full membership with affiliate membership available only for clubs or “societies” which did not have their own courts and equipment. The redrafting of the Constitution inadvertently left a loophole enabling established clubs to apply for affiliate membership. Whilst only a small number of clubs have taken advantage of this, it is an un-intentional consequence which Council considered unfair to the majority.

This loophole has been rectified by amending the constitution; these changes being approved by the AGM on 17th October.

When CA membership became available to members of CA member clubs the former Tournament Member category was renamed Premium Member and the grade of Standard Member established. A principal benefit of Premium Membership is a reduction in tournament entry fees. Some tournaments give priority to Premium Members in the event that they are over-subscribed and furthermore certain events are restricted to Premium members. It is recommended that these restrictions are removed.

No changes to Supporter, Overseas or Young Persons membership are proposed.

Dave Kibble:

A working group was established to review the CA website and members will already have seen some improvements to this, but a major re-vamp is in the wings. Work continues.

The Fixtures Calendar and online entry system has been overhauled, largely a behind the scenes piece of work but now allowing clubs to directly maintain their entries.

I also support all the CA committees to maintain and improve the information they publish on the website.

In return for a modest fee, I have continued to develop the CA Membership Database and to support clubs and the CA office in its implementation and refinement. We are working with a few selected clubs to make it fit-for-purpose as a club tool.

Conclusion

We would like to thank the SWF Federation for their continuing work, and in particular Paul Francis and Stephen Custance-Baker for their Zoom sessions - a very helpful innovation.

As Representatives (not delegates) we always have in the forefront of our minds the interests of the South West.

As members of Council we are also aware that there are occasions when we are required to take the broadest view in the interests of our sport.

Looking ahead to 2021: Discussion summary

The original aims of the session were:

- To identify clubs' needs and priorities in the context of CA and SWF themes
- To consider ways of addressing these
- To find volunteers to help do this

The discussion took on a less structured form - people were rather 'Zoomed-out' - so the topic will be re-visited at our next Zoom meeting.

The following points were raised by clubs:

- Coaching
 - There was an apparent lack of clarity concerning the whereabouts and availability of coaches in the region
 - Richard Jackson said he contacts coaches each year and has details of this
 - Noted the potential for further refinement of such a system
 - It is anticipated that coaching will continue next year, with hopefully greater opportunities for face-to-face sessions
 - Coaching can be arranged if there is a demand - noted scope for better communication between supply and demand
 - Often a simple phrase is enough to set people off in the right direction
 - Coaching is most effective when it is backed up with practice!
 - Conversion from GC to AC would be helpful
 - There is scope for balancing on-line coaching with face-to-face
 - Discussed the value of Coach Training Courses and how these might correlate with coaching skills
 - Recognized there may be other ways of training coaches and the potential of regular refresher courses
 - Richard noted the CA Coaching Committee is reviewing various aspects of this area
 - See Croquet Gazette issue 387 p24-5 to read a recent article by Sarah Hayes on this - and she has an excellent column in each issue.
- Covid
 - Discussed the guidelines issued by CA
 - Some clubs have problems getting their members to comply
- Lawn booking systems
 - Ffi see CA Club Webinar:
Court Booking Systems: <https://www.youtube.com/watch?v=iBDAFjmfSLI>
- Catering
 - Concern expressed about the etiquette surrounding catering at League matches and wondered if SWF guidance would be helpful:
"Some host clubs provide lunch and tea, some lunch only, some tea only and some tell the visiting team to bring their own."
 - There was a lack of conviction that this would prove helpful but would be considered
 - Noted that with Covid restrictions in place, self-catering is the order of the day
- CA club size criteria and fees
 - Views were expressed and people were advised to let Peter Nelson have these to feed into the review group
 - That large/small lawn distinction not v helpful - may not relate to membership numbers
 - Levy system is unfair
- Abbey noted they will probably need to play all their League matches away next year due to the state of the lawns

- There are precedents for this

The call for more people to become involved in the work of the committee and its various areas of work was made.

Further information will be forthcoming but initial suggestions are:

- by being co-opted to the committee
- by offering to work with the committee, perhaps as part of a small team, on a particular topic - e.g.
 - Coaching officer
 - Handicapping officer
 - Website Liaison officer
 - Social media / communications
 - Safeguarding officer
