## 13) AOB

- a) At Bristol CC's AGM one member asked why whites were compulsory in competitions. Apparently, there is something of a movement pointing out this could be discriminatory vis a vis e.g. menstruating women, people with urinary or bowel incontinence. They requested this be discussed by SWF in the first instance.
  - i) SWF is supportive of this and also concerned that the current dress code may be affecting recruitment and will raise it at next Feds Forum. **Action: Paul / Tony**
- b) C&P CC new club house is functioning and they are considering having open play day by invitation to neighbouring clubs
- c) Stephen invite for reps and refs at finals going out soon
- d) Stephen notice of forthcoming coaching pods at Taunton will go in Cygnet
- e) Stephen will be circulating his AGC paper to those involved in its development and is considering submitting an article to the Gazette
  - i) We will be surveying our members on their views again in the autumn after a season's play

## **Appendix 1**



#### Summary of Expected Income & Expenditure for 2023

I refer to the table on page 3, this shows the budget for 2023, the actual income & expenditure for the period up to March 16th, the expected income & expenditure for the full year and in the last column the difference between the expected position and the budget.

Income is forecast to be  $\pounds$ 62 lower than expected in the budget principally due to a slightly lower than anticipated entry in the Nailsea & Buldleigh Short Croquet Tournaments (55 entries vs expected 60).

Expenses are currently expected to be in line with the forecast, although it is early in the financial year to be confident of the final outcome.

In summary the net impact is that there is a projected deficit for the year of around £529 vs the expected deficit of £470. This slightly higher deficit can be adequately covered by reserves.

#### **Creditors / Debtors**

Debtors - c. £1,000 payment from the Bears Residual Fund

#### **Balance Sheet**

At March 13th there was £6,223 cash at Bank excluding the Judith Moore Bursary (see below),

#### Judith Moore Bursary

The February GC Referees Course was supported by the Judith Moore Bursary Fund with a net payment from the fund amounting to  $\pm 201$ , and the cash balance is now  $\pm 4,799$ .

It is anticipated that payments from the Fund of c.  $\pounds$ 1,000 will be made in the current year to support coaching projects as outlined at the AGM. It is too early to give an updated estimate.

#### Banking

A Savings account has now been opened with Nat West and this will pay a modest interest rate on a portion of the reserves held by the Federation.

## **Development Report**

#### New Club

Cripplegate Bowls Club (Worcester) were visited in late February to discuss the introduction of a croquet section.

The club is about to register with the CA and SWF with Klim Seabright ready to support this Spring. They will have one court dedicated to croquet, it's in pretty good condition and perfectly flat.

#### Next Generation

Bath, Bradford on Avon, Nailsea and Worcester Norton will be taking part in this summer's pilot programme. This is equivalent to over 50% of the national programme.

#### Swanage: Re-location

The club's negotiations with a local builder have stalled.

The back up option, to play temporarily on a school field has been agreed.

In 2023, all Swanage league fixtures will be away matches.

## **Coaching Report**

#### Examining Coach

In mid-March, PF attended/assisted at a two day coaching course at Southwick.

As a result he has been recommended to become an Examining Coach. Official confirmation to follow from the Chair of the Coaching Committee.

This means we can now offer hybrid course in 2023. PF will be qualified to deliver club level and grade 1 courses for GC/AC.
